### 5.16.010 - Definitions.

The following definitions shall apply to the provisions of this chapter:

A. *"Charitable organization"* means:

1. Any benevolent, eleemosynary, educational, social, recreational, or fraternal organization, or any other person having or purporting to have a charitable nature; and
2. Which solicits or solicits and collects contributions for any charitable purpose.

B. *"Charitable"* means any oral or written request for a contribution, including the solicitor's offer or attempt to sell any property, rights, services, or other thing in connection with which:

1. Any appeal is made for any charitable purpose; or
2. The name of any charitable organization is used as an inducement for consummating the sale; or
3. Any statement is made which implies that the whole or any part of the proceeds of the sale will be applied toward any charitable purpose or donated to any charitable organization.

The solicitation shall be deemed completed when made, whether or not the person making it receives any contribution or makes any sale.

### 5.16.020 - Permit—Required.

No person shall solicit for charitable purposes in the City without first having obtained a permit from the City Clerk, for which no fee shall be assessed. This permit requirement shall not apply to any solicitation which involves no person-to-person contact within the City, nor to organizations exempt under Ch. 19.09 RCW.

### 5.16.030 - Compliance with state law.

No person shall be granted a permit to solicit for charitable purposes, unless said organization is registered pursuant to Ch. 19.09 RCW, as now enacted or hereafter amended.

**5.16.040 - Permit—Application—Contents.**

In addition to all other information required of an applicant for a business license, an applicant for a charitable solicitation permit shall provide the following:

- A. Name and address of all persons expected to take part in the solicitation;
- B. Name and address of charitable organization for which contributions are solicited.

**5.16.050 - Permit—Application—Affidavit.**

Any person applying for a permit to solicit, pursuant to the terms of this chapter, shall sign an affidavit attesting that:

- A. All information contained in the application is true and correct;
- B. The applicant is authorized to solicit on behalf of the charitable organization listed in the application.

**5.16.060 - Permit—Carried by solicitor.**

Any person soliciting for charitable purposes in the City shall carry a valid permit or reasonable facsimile thereof on his person while soliciting. Each solicitor shall produce the permit upon demand of any person who is being solicited, or upon the demand of any authorized City official.

### **5.64.010 - Permit—Required.**

No person shall solicit for religious purposes in the City without having first obtained a permit from the City Clerk for which no fee shall be assessed.

### **5.64.020 - Permit—Application—Contents.**

The application shall contain the following:

- A. Name and address of the applicant;
- B. Name and address of the religious organization;
- C. Corporate name and principal place of business of the religious organization;
- D. Proof of membership in the religious organization as to each individual applicant;
- E. Sample of materials which the applicant intends to distribute, whether or not contributions will be solicited for those materials;
- F. Statement as to any salary or compensation received by the applicant from the religious organization.

### **5.64.030 - Permit—Application—Affidavit.**

Any person requesting a permit to solicit pursuant to the terms of this chapter shall sign an affidavit attesting that:

- A. All information contained in the application is true and correct;
- B. The applicant will solicit for religious purposes only.

### **5.64.040 - Permit—Renewal.**

Any permit issued pursuant to the terms of this chapter shall be valid for a period of one year from date of issuance and may be renewed or reissued.

**5.64.050 - Permit—Carried on person.**

Any person soliciting for religious purposes in the City shall carry a valid permit from the City on his person while soliciting. Each solicitor shall produce the permit upon demand of any person who is being solicited, or upon the demand of any authorized City official.

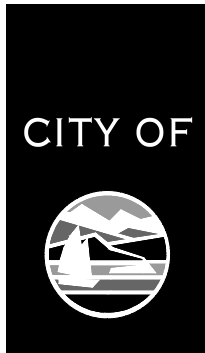

**5.64.060 - Regulated.**

The following regulations shall apply to all persons soliciting for religious purposes in the City:

- A. No more than two members of any religious organization may approach any individual or group of persons for the purpose of soliciting contributions or expressing their religious beliefs at any one time.
- B. Soliciting in a residential neighborhood shall be limited to the hours of 10:00 a.m. to 7:00 p.m.
- C. No person shall solicit within ten feet of the entrance or exit, ingress or egress of any retail establishment, public building or structure, without the express written permission of the owner or other authorized person.
