

Bathroom water savings

When installed in tank type toilets, a Toilet Tummy will save nearly 1 gallon of water every time you flush. Install it in seconds without the use of tools.



Toilet Tummys are not recommended for use with water saving toilets or if you have a low-flow toilet tank.

Shower savings

Save energy and water by installing a new showerhead.

This energy saving showerhead provides a relaxing massage, and an adjustable spray feature.



Air Leakage savings

Install electrical outlet and switch plate gaskets between cover plates and wallboard to help reduce drafts. Gaskets should be installed on both interior and exterior walls.

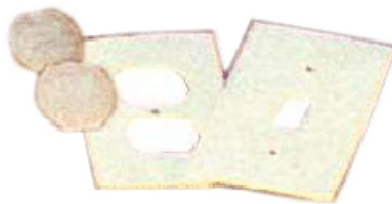
Kitchen sink savings



The swivel capabilities and variable spray modes make this water and energy saver faucet aerator a real winner. Reach every corner of your kitchen sink with a forceful spray or stream flow pattern.

Other sink savings

A water and energy saving faucet aerator can reduce splash and noise generation too. A low-flow faucet aerator can be installed in bathrooms and utility rooms to minimize water and energy use. Faucet aerators can become plugged and may need to be replaced periodically.
